PARTICIPATORY RURAL APPRAISAL (PRA) TECHNIQUE AS AN ALTERNATIVE FOR DEVELOPMENT OF TOURISM VILLAGE POTENTIAL IN SELUR VILLAGE, NGRAYUN DISTRICT, PONOROGO REGENCY

packages is based on the condition of the potential of the tourist village, both physical, socio-economic and cultural potentials as well as the willingness of the community to actively participate.
